**1974-1979** Study of biological sciences, vegetal branch, at the University of La Laguna.

**1981** Completion of the career with a degree thesis: "*contribution to the floristic and ecological vegetation makes of the malpaís de Güümar, Tenerife*".

**1981-1983** Studies to obtain a Master of Science in agriculture and tropical forestry at the University of Göttingen, Germany, including a research paper entitled: "*essay on floral inhibition and retardation in floral differentiation through the application of gibberellins in young mango trees*", which was held in the Department of Fruit of the then National Institute of agrarian research (INIA) in Valle Guerra, Tenerife, to obtain the master's degree.

**1985** Move to Fuerteventura.
